# LISTSERV

It has been quite a year, and the ongoing value of the ADFM listserv has been increasingly apparent during the COVID-19 pandemic, when idea and resource sharing made the listserv more active than ever! In late fall 2020, we were notified that the University of Wisconsin would no longer be able to host our listserv. We have spent the last few months searching for the best solution for continued engagement for our membership and would like to give our deep thanks to the University of Wisconsin Department of Family Medicine & Community Health for their many years of supporting our listservs!

As of February 1, 2021, we have moved to a new communications/community platform, similar to the one utilized by STFM and NAPCRG. This new platform, ADFM Connect, has a listserv feature similar to what we are all used to. The new platform will also allow you some options that our members have been requesting for a number of years – the option to set your individual preferences for a daily digest or receiving each message as a separate email to your inbox and the ability to easily view an archive of messages. The community space will also allow easier resource sharing for our committees and programs and also features a place where all resources sent on the listserv will be saved & housed for future reference.



# MEMBERSHIP

We ended the 2020 program year with 103 Chair + Administrator and 61 Chair-only memberships (+1 administrator-only membership at an institution with a leadership transition), a total of 165 members – the most ever! We hope to continue this trend in 2021.

As of December 31, 2020, we have 99 paid memberships – 52 Chair + Administrator, 43 Chair only, and 4 Administrator only (i.e. chair dues in process). Please make sure to renew if you haven't already done so!

Our Associate Membership category, which started in 2018, continues to grow. In 2020, we had 57 Associate Members, including 10 Associate Administrator members.

The option to add an Associate Member has been a valuable one for many departments and we have appreciated the opportunities for enhanced diversity, greater breadth of knowledge across the organization, and leadership development it has provided. We will continue to assess the impact that this new category of membership is having on the organization.
